

# A.C.C. Approval

Any Resident planning to change the exterior of their property must obtain approval from the A.C.C. Chairman. North Strabane Township will not issue a building permit to any resident of Glencannon unless they have this approval from the association. Approval must be obtained for decks, doors, windows, sidewalks, patios, sheds, painting, etc.

A \$50 fine may be assessed for failure to submit the ACC form with proper approval.

# Selling Your Property?

If you are planning to sell your property you will need a "Resale Certificate" signed by a GHA Board Member and the GHA Secretary. The Resale Certificate is issued when all GHA dues and assessments have been received by GHA resulting in a zero balance owed. The Resale Certificate is required for your home Closing.

As a reminder under Act 180, the Association has ten days to provide the Resale Certificate and other items to the seller. Please contact the GHA Secretary as soon as possible so that your Resale Certificate can be prepared.

There is a fee of \$75 for a Resale Certificate.

# Attorney Fee Policy

Residents who fail to pay the monthly \$43 assessment for five months or more can expect an official warning letter from Glencannon Homes Association. Failure to respond will result in a letter from the Glencannon Attorney and a \$100 letter drafting fee will be added to the amount owed. Homeowners that force the Attorney file a lien on their property (for lack of payment) will also have those fees added to their account.

## **Resident question of the month**

### If I go to the pool, what are the requirements for mask wearing, when, where?

When you enter the pool gate, you are required to have a mask on. When you get to your chair, you are to wipe down the chair with a Clorox wipe (provided). Assuming you are only sitting with your immediate household (6 ft. away from anyone else), you may remove your mask and you will not have to wear a mask in the pool. If you get up to use the restroom or talk to someone, a mask will be required along with social distancing. If you are sitting on the edge of the pool speaking to someone (not in your household) you are required to be 6 ft. away. When you leave, you are to wipe down your chair(s) with Clorox wipes and wear a mask on your way out.

Dog Laws

Please remember that Pennsylvania and the township of North Strabane have laws pertaining to DOGS.

Pennsylvania State Law: All dogs must be under control and may not be allowed to run at large. Dogs are personal property and owners are responsible for damages caused by their dogs. This means that when your dog is not on your property, it must be under direct control of you or a handler. The best way to control your dog is with a leash.

### North Strabane Township Ordinance:

It shall be unlawful for the owner of any dog or dogs to allow or permit such dog or dogs to run at large in the township of North Strabane.

We ask that all residents please clean up after your pets. Thank you for your cooperation.

Glencannon ACC regulations require that GARBAGE CONTAINERS are to be stored indoors or inconspicuously outdoors (not in front of your residence).

Garbage containers should be placed at the curb no earlier than 5:00 p.m. the night before collection day,

and must be removed the next day.

## **ROLL CALL**

Terry Creighan – President, Shawn Beard – Vice President, Jim Byer, Dave Wheeler and Jen Marsh.

Becca Ware, John Ackerman and Doug Krantz not present and excused.

## FINANCIALS

The financial reports that were distributed last week were discussed and Mr. Byer made a motion to approve. Mr. Beard seconded the motion. Vote: Mr. Creighan – yes, Ms. Marsh – yes and Mr. Wheeler – yes.

## COMMONS

The board discussed that the county approved the Emergency Action Plan for the work on the pond. State approval is now needed as the next step. It is <u>not</u> likely that work will be done on the pond this year.

## REC

The board discussed that the pool has been

operating well. There were several tables that broke and two new tables have been purchased and should be arriving soon.

## ACC

There were multiple requests over the last month and all were approved.

## **OPEN DISCUSSION**

A resident was present and discussed the parking pads at the foot of Glen Springs circle and Old Meadow. He said that the parking pads need lines on them to fit more cars. The board let him know that there will be upcoming asphalt projects, and this will be added to the list.

Another resident present asked about the entry on Glencannon Drive. He would like to see signs showing that each side of the island is one way.

Meeting adjourned at 7:20pm.

# **Glencannon Pond Repairs – Project Status Update**

**Permit Applications:** 

- a) Township Grading Permit a copy of the Stormwater Consistency Letter from the Township Engineer.
   Harshman will need to follow up with the Township with copies of the approved permits from DEP, WCCD, etc.
   once they have been obtained. There will be a permit fee to pick up the permit from the Township.
- b) A representative from DEP is awaiting a signed FP-001 form for clean fill. A representative has already signed the form as the report preparer. We are waiting to receive a signed copy of the form from a contractor who owns a potential disposal site nearby that can take the dredge material. They are waiting for the Washington County Conservation District to sign off on a permit of their own first before they sign the FP-001 form. We will continue coordinating with them.
- c) Joint Permit Application (DOA) The DOA has requested a copy of the most recent application documents. We are awaiting the signed FP-001 Form from the disposal company to send to them with the other documents.
- d) NPDES (National Pollutant Discharge Elimination System) Permit The DOA has requested a copy of the most recent application documents. We are awaiting the signed FP-001 Form from the disposal company to send to them with the other documents.
- e) Chapter 105 Dam Amendment/Authorization Letter & Dam Permit DEP Comments received for the dam permit have mostly been addressed. The only remaining comment that needs addressed is the finalized revision of the Emergency Action Plan (EAP). The County Safety Department has finally sent us a copy of the signed signature page of the EAP on July 7th. We will now work on getting the EAP submitted to PEMA and DEP for review and signatures. Once the EAP has received all signatures and has been finalized, a comment response will be provided to DEP addressing their comments.

f) General Permit 7 (GP-7) – Approved by WCCD.

Miscellaneous:

a) Once all permits have been obtained, we can start preparing the bid package and bidding the project.

- b) The 2020 Covid-19 pandemic has caused delays and we will have to look to the summer of 2021 to do the work on the pond.
- c) The field behind 101 Hunting Creek Road has been evaluated as a disposal location, and while it can be used to dispose of some of the material after proper preparation, it will not sustain all of it.

# Pool hours when school returns

Starting August 24th the pool will have shortened hours on weekdays (regardless of school being open or closed).

At the time of printing this newsletter, Canon-McMillan school district will start classes Thursday, August 27th with either ALL online or hybrid 2 days a week with online learning the rest of the week.

Our plan (at this time) is to have the pool open from **noon to 4:00 pm** August 24th, 25th and 26th and 4:00 pm to 8:00 pm August 27th and 28th.

The first week of September (up to Labor Day) we will have the usual back to school hours of 4:00 pm to 8:00 pm.

# Notice:

Vehicles without current registration stickers are <u>not</u> permitted to be parked in Glencannon commons parking pads. In addition, vehicles parked in commons parking for long periods of time will be researched for resident ownership. These vehicles will be towed

at the owners expense.

In addition, glass is no longer acceptable because it can break and contaminate other recyclable items.

# Coronavirus Disease 2019 (COVID-19)

### **Know How it Spreads**

- There is currently no vaccine to prevent coronavirus disease 2019 (COVID-19).
- The best way to prevent illness is to avoid being exposed to this virus.
- The virus is thought to spread mainly from person-to-person. Between people who are in close contact with one another (within about 6 feet).
- Through respiratory droplets produced when an infected person coughs or sneezes.
- These droplets can land in the mouths or noses of people who are nearby or possibly be inhaled into the lungs.

### Take steps to protect yourself

- Wash your hands often with soap and water for at least 20 seconds especially after you have been in a public place, or after blowing your nose, coughing, or sneezing.
- If soap and water are not readily available, use a hand sanitizer that contains at least 60% alcohol. Cover all
  surfaces of your hands and rub them together until they feel dry.
- Avoid touching your eyes, nose, and mouth with unwashed hands.
- Avoid close contact with people who are sick
- Put distance between yourself and other people if COVID-19 is spreading in your community. This is especially
  important for people who are at higher risk of getting very sick.

### Take steps to protect others

- Stay home if you are sick, except to get medical care. Learn what to do if you are sick.
- Cover your mouth and nose with a tissue when you cough or sneeze or use the inside of your elbow.
- Throw used tissues in the trash.
- Immediately wash your hands with soap and water for at least 20 seconds. If soap and water are not readily available, clean your hands with a hand sanitizer that contains at least 60% alcohol.
- If you are sick: You should wear a facemask when you are around other people.
- Everyone should wear a mask in public settings and when around people who don't live in your household, especially when other social distancing measures are difficult to maintain. Facemasks normally used for caregivers (N-95 masks) may be in short supply and you should avoid using them.

### **Clean and disinfect**

- Clean AND disinfect frequently touched surfaces daily. This includes tables, doorknobs, light switches, countertops, handles, desks, phones, keyboards, toilets, faucets, and sinks.
- If surfaces are dirty, clean them: Use detergent or soap and water prior to disinfection.

### THEFT PREVENTION NOTICE:

This is a reminder for residents to please lock their vehicle, home, and garage doors. North Strabane Township was recently named one of the safest communities in Pennsylvania. However, there have been several areas throughout Washington County where person(s) have entered unlocked vehicles and/or garages to steal items. Officers from North Strabane Township and surrounding departments have arrested numerous actors involved in this criminal activity, but the crime continues...

### DON'T BE THE NEXT VICTIM:

There are small steps you can take to avoid becoming the next victim of theft. Criminals are looking for easy targets, often taking the path of least resistance. Most property thefts can be prevented by simply **locking your windows, home, garage, and vehicle doors.**

**Call 9-1-1.** If you see something that appears to be suspicious, trust your instincts and report it. The sooner you call 9-1-1, the quicker the police will arrive. Be a good witness and do NOT confront anyone.



# Glencannon Recreational Center RULES AND REGULATIONS

### ONLY RESIDENTS CURRENT IN THEIR ASSESSMENTS MAY USE THE RECREATIONAL FACILITIES. Violation of the following rules will result in revocation of swimming privileges.

### **POOL RULES:**

- 1. No diving or flipping into the pool at anytime.
- 2. Running and horseplay in the pool area is prohibited.
- 3. Water games in the pool are permitted only with the consent of the guard and when they don't interfere with the enjoyment of the pool by others.
- 4. Soft throwing and water balls, kickboards and other water equipment (rafts etc.) may be used only with the consent of the guard.
- 5. Non-swimmers must stay in the shallow end of the pool.
- 6. Please refrain from talking to the guard on duty except to request information.
- 7. Children 12 years of age and under will not be permitted in the pool area unless accompanied by a parent or an agent of the parent acting as the guardian. Authorization shall be submitted to the guard in writing. CHILDREN MUST BE WATCHED BY THE GUARDIAN AT ALL TIMES! A GUARDIAN MUST BE 16 YEARS OF AGE OR OLDER.
- 8. Children 12 years of age and under who have not been certified as competent swimmers cannot be in the deep end of the pool. All children wearing water wings or flotation devices of any kind are considered non-swimmers by the staff and need to be accompanied/supervised by an adult or guardian in the shallow end of pool at all times. Children that have passed the deep water competency test four years in a row are exempt from repeating the test at the discretion of the guards.
- 9. Each parent is responsible for the safety of his/her child at the baby pool and must supervise at pool side.
- 10. Members and guests are permitted to enter the pool area only through the bathhouse gate.
- 11. Entering the pool area at any time when it is closed is prohibited.
- 12. Glass, sharp objects, or other dangerous articles are not permitted in the pool area at any time.
- 13. Throwing of rocks or other foreign materials in or around the pool is prohibited.
- 14. Please use the available trash cans keeping the pool area clean for the next guests.
- 15. Pets ARE NOT permitted in the pool area during operating hours.
- 16. NO ALCOHOLIC BEVERAGES are permitted in the pool area at any time.
- 17. Glencannon Homes Association is not responsible for any valuables lost in the pool area.
- 18. Smoking, food and drinks and gum are not permitted in the pools or on the concrete apron around the pools at any time.
- 19. All members and guests using the recreational facilities must respect the rights and property of the neighboring residents at all times.
- 20. All persons must leave the pool at any time when directed to do so by the guard(s).
- 21. The baby pool is only for infants and toddlers up to age 4 years old.
- 22. Only guard chairs are permitted on the concrete apron near the pools. Chairs are not permitted in the baby pool.
- 23. No loud music by individuals interfering with the enjoyment of the pool by others will be allowed.
- 24. Chairs are available on a first come, first serve basis.
- 25. Parties will not be available (at least) through mid-July, both pavilion rental and after hours.
- 26. No person showing evidence of a communicable disease, bodily discharges, open blisters or cuts and bandages will be allowed entry to the swimming pool area.
- 27. Persons suspected of being under the influence of drugs/alcohol shall be prohibited from entering the pool.

28. Pool Management reserves the right to eject anyone (for the day) for conduct issues. Recurring violators will be referred to the Board of Directors for disciplinary action.

### POOL SCHEDULE:

- 1. The pool will open for the season on a daily basis from (Saturday) June 13 to Labor Day.
- The pool hours (weather permitting) will be 12:00 pm 8:00 pm Monday through Friday and 11:00 am - 8:00 pm on Saturdays and Sundays for the pool season; pool opens at 11:00 am on holidays. Starting June 17, 2020 and continuing through August 19, 2020, Wednesday "night swims," will be available, the pool will be open 12:00 pm - 10:00 pm.
- 3. A rest period for Adult Swim will occur promptly during the last 15 minutes of each hour. All children (17 years old and younger) must leave the pool for the mandatory rest period. During this time, children (5 and up) cannot be in the Baby Pool and are to be in the grass areas, pavilion/tennis court area. Children (2 and under) are permitted in the pool with their parent/guardian during Adult Swim.
- 4. The pool will open at 4:00 pm on school days.
- 5. The pool may be closed during the hours of inclement weather, at the discretion of Pool Management.

### **GUEST REGULATIONS:**

#### Members may bring only 2 guests (per household) at any time, subject to the following regulations.

- 1. Any Glencannon Resident in arrears on assessment cannot be a guest of a member in good standing.
- 2. Guests must be accompanied by a member in good standing and obtain a guest pool pass. Residents MUST stay with their guests at all times. There is a maximum of 2 guests (per household) permitted for the 2020 season due to the Covid-19 restrictions.
- Guest fees: \$3.00 per person daily admissions (children 5 and under are free). A season guest pass will be available for \$35.00. (good for one individual person only—name will be placed on the pass). A transferrable pass may be purchased for \$50.00. <u>All guests must be accompanied by a resident</u>. There is no fee for use of tennis courts when accompanied by a Glencannon resident.
- 4. A vacation pass is available for \$15.00. Purpose: In the event an association member cannot be present when out of town guests are visiting so these guests feel comfortable using our pool facilities.
- **DIRECTIONS:** The member must fill out the vacation pass form and return it to the pool manager. Once approved/ disapproved, the member will be notified (within two weeks after the request). Payment must be paid in full one day prior to arrival date. Only after payment is made and the pass is filled out will the vacation pass(es) be issued (this will be done at the pool).
- **RELEASE FORM:** This can be filled out anytime and brought to the pool when picking up the pass(es). If anyone is less than 18 years of age, a parent or guardian must sign the form on their behalf.
- VACATION TIME: Seven days (one week) is the maximum time for each vacation request, but there is no limit on the number of requests.
- PAVILION RENTAL: NOT AVAILABLE UNTIL FURTHER NOTICE residents may use the pavilion informally during regular pool hours while practicing social distancing.

### AFTER HOURS POOL USAGE: NOT AVAILABLE UNTIL FURTHER NOTICE

OTHER COMMONS FACILITIES: Tennis, Volleyball, Pavilion (10:00 a.m. to Dusk weather permitting)

- 1. Only members in good standing and their guests can use the courts. Guests must be accompanied by members at all times.
- 2. Reservations for the courts may be made with the Association Secretary. Use of the tennis court and volleyball court will be limited to two hour increments. Anyone wishing to use the softball field for an organized event must reserve the date and time at least one week in advance through the Secretary. Fees may be charged depending on the type of reservation.
- 3. Hoverboards, skateboards, scooters and rollerblades ARE NOT permitted at the pool or courts at any time.
- 4. Any individual playing tennis/volleyball/basketball must shower before swimming.
  - Damage to any property in the recreation area by any member or guest will result in the liability of the responsible party for repairs or replacements necessary as a result of their actions.

### Additional COVID-19 Regulations:

Social Distancing is required at all times, guests are required to wipe down their chairs with Clorox wipes before and after using a lounge chair, masks are to be worn when addressing anyone in the pool area, anyone feeling ill should stay home, all parties are suspended until further notice.


