

A.C.C. Approval

Any Resident planning to change the exterior of their property must obtain approval from the A.C.C. Chairman. North Strabane Township will not issue a building permit to any resident of Glencannon unless they have this approval from the association. Approval must be obtained for decks, doors, windows, sidewalks, patios, sheds, painting, etc.

A \$50 fine may be assessed for failure to submit the ACC form with proper approval.

Selling Your Property?

If you are planning to sell your property you will need a "Resale Certificate" signed by a GHA Board Member and the GHA Secretary. The Resale Certificate is issued when all GHA dues and assessments have been received by GHA resulting in a zero balance owed. The Resale Certificate is required for your home Closing.

As a reminder under Act 180, the Association has ten days to provide the Resale Certificate and other items to the seller. Please contact the GHA Secretary as soon as possible so that your Resale Certificate can be prepared.

There is a fee of \$75 for a Resale Certificate.

Attorney Fee Policy

Residents who fail to pay the monthly \$43 assessment for five months or more can expect an official warning letter from Glencannon Homes Association. Failure to respond will result in a letter from the Glencannon Attorney and a \$100 letter drafting fee will be added to the amount owed. Homeowners that force the Attorney file a lien on their property (for lack of payment) will also have those fees added to their account.

Dave Wheeler and Rebecca Ware not present and excused.

Mr. Creighan called the meeting to order at 6:30 pm.

Vince Eannace from Stelmack, Dobransky and Eannace was present to discuss the 2018 Audit. He reviewed all aspects of the audit and noted all information to be accurate and consistent from year to year. The board discussed additional questions regarding the good steward program, the interest accounts and estimated taxes.

FINANCIALS

The board discussed the financial reports that were provided last month.

COMMONS

The board discussed that bids are needed for the 2020-2021 Landscaping contract. The bids will be obtained focusing on the beds as a possible separate contract. Changes to the contract were discussed as well. The playground painting and repairs were discussed as well as the cost details. The aerator was also removed for the year.

OLD BUSINESS

The board discussed having a meeting with the Harshman CE Group in the next few months to be updated on the current status and progress. The emergency action plan is needed for the engineers.

NEW BUSINESS

The garbage contract for 2020 was also discussed and bids are being obtained.

The board discussed that due to Republic Services raising their rates mid-contract, it was determined that the contract can be ended early with no penalty. Notification to them has to occur by mid-December if another company is chosen. The details of pricing were discussed and that the cost of both trash removal and recycling has increased for all companies.

The 2020 budget was discussed and a draft copy was distributed. Any questions or changes are to be submitted over the next month.

The meeting times for 2020 were also discussed. Mr. Creighan made a motion to continue the Monthly Meetings of the Directors for the second Tuesday of each month with the exception of the March 2020 meeting and the Annual meeting being the third Tuesday in March. Mr. Krantz seconded the motion. Vote: Mr. Beard – yes, Mr. Sacco – yes, Mr. Byer – yes and Mr. Ackerman – yes.

Glencannon ACC regulations require that GARBAGE CONTAINERS are to be stored indoors or inconspicuously outdoors (not in front of your residence).

Garbage containers should be placed at the curb **no earlier than 5:00 p.m. the night before collection day,** and must be removed the next day. also what requires approval by the township. He also talked to the board about other ideas he has to fix the problem with collaboration from his neighbors.

Another resident was present and discussed the abandoned car in the pool parking lot that needs removed. The board discussed with him that they will be tagged soon. This resident also talked about information he heard about development in the area. Lastly, he discussed a particular pet that is being left to roam the community and has become a nuisance. This resident will be notified.

Dog Laws

Please remember that Pennsylvania and the township of North Strabane have laws pertaining to DOGS.

Pennsylvania State Law: All dogs must be under control and may not be allowed to run at large. Dogs are personal property and owners are responsible for damages caused by their dogs. This means that when your dog is not on your property, it must be under direct control of you or a handler. The best way to control your dog is with a leash.

North Strabane Township Ordinance:

It shall be unlawful for the owner of any dog or dogs to allow or permit such dog or dogs to run at large in the township of North Strabane.


