July Board Meeting and Annual Meeting

The next Glencannon Board Meeting will be held on Tuesday, July 12, 2011 at 8:00 p.m. at the Glencannon Pool Pavilion.

The Annual Meeting will be held immediately following the regular meeting.

All residents are invited to attend!

ELECTION INFORMATION

All residents were mailed a ballot, return envelope, and explanatory letter. The return envelope must be filled out and the envelope and ballot must be returned together to be counted. No individual ballots will be counted unless accompanied by the completed return envelope.

The envelopes may be returned by mail, given to the secretary in person, or given to the secretary by another member at the Annual Meeting. If you are mailing your ballot, we recommend mailing it no later than <u>July 7th</u> to ensure that it is received prior to the Annual Meeting on July 12th.

The Board has given the candidates in the Townhouse category the opportunity to write a brief note introducing themselves to the residents of Glencannon. (The candidates in the other two categories are running unopposed.) Their notes appear below.

North Strabane Township will not issue a building permit to any resident of Glencannon unless they have this approval from the Association. As a reminder, under Act 180, the Association has 10 days to provide the resale certificate and other items to the seller. Please notify the Association Secretary as soon as possible so that a resale certificate can be prepared.

Pond Vote Results

We have received a request to publish the number of votes that were submitted for the vote regarding the pond. Here they are:

370 lots were current on assessments as of the day the votes were due. Of these, 260 residents submitted votes. 208 voted to get rid of the pond, 49 voted to keep the pond, and 3 submitted written abstentions.

Glencannon Regular Meeting Minutes

June 14, 2011

Board members present: Vice President Dave Sarver, Lisa Ackerman, Tony Sacco, Richard Flood, Rita Manolas, John Morton, and Terry Creighan

Meeting was called to order by Mr. Sarver at 8:02 p.m.

FINANCIALS: The Board reviewed the financial information for May 2011 that had been distributed prior to the meeting. Mr. Sacco stated that he had not yet received the detailed invoice from Sherwood Pools that he had requested. Mr. Sarver asked Patrick Hogan Sr. to respond. Mr. Hogan stated that Patrick Hogan Jr. is working on obtaining this invoice for Mr. Sacco.

Mr. Sarver made a motion to approve the May financials. Mr. Flood seconded the motion. Vote: 5 yes (Mr. Sarver, Mr. Flood, Mr. Creighan, Ms. Manolas, and Mr. Morton), 1 no (Mr. Sacco) and 1 abstention (Mrs. Ackerman)

COMMONS: Mr. Sarver stated that it needs to be determined if two trees near the pond are on common property or not. He will check to see if there are stakes in the ground in that area.

Mrs. Ackerman asked if the merry-go-round at playground "A" has been painted yet. Mr. Sarver stated that it has been painted but it is peeling and will need to be looked at by Elite. Mrs. Ackerman also requested that Elite check the swing at playground "A" that has been positioned higher than it should be several times. Mr. Sarver stated that it has already been moved down.

Mr. Sacco asked about the recovery amounts mentioned in the pond lawsuit update in the June newsletter. Mr. Sacco said that the legal fees would surpass the amount of the DEP mandated work according to the consulting engineer. He suggested having the residents vote on continuing the lawsuit. Mrs. Ackerman stated that the Board already unanimously agreed to continue the lawsuit. [For clarification, Mr. Sacco and Mr. Morton were not in attendance for the April 19, 2011 Executive Meeting when the vote mentioned by Mrs. Ackerman occurred.] Board members, along with several residents in attendance, engaged in discussion of the lawsuit. Mr. Sarver said that he will ask Eckert Seamans for clarification of what their \$300,000 figure consists of.

Mr. Flood said that there are two or three tall trees at the corner of Hunting Creek Road and Hickory Circle that seem to be in danger of falling onto a resident's property. Mr. Sarver said that Elite cannot work on tall trees. Mrs. Ackerman added that there is a tree on upper Hunting Creek that needs attention as well.

REC CENTER: Mr. Sarver stated that the wash-out area at the pool is complete and is being used often. Mr. Sarver asked Mr. Hogan Sr. to explain the issues with the baby pool. Mr. Hogan stated that the baby pool was not winterized properly last year, and there is a break in the line off of the main drain that runs to the pump room. The line is broken underneath the concrete. The big pool was also not winterized properly last year, and they have had some work done in the pump room. They are still waiting for the pump to come in, and they are contracting with Sherwood Pools for the mechanical work. Mr. Hogan said that they may need to shut down the pool for half a day to replace the pump. Mr. Hogan stated that their recommendation to the Board is to wait until next year to repair the baby pool because it would be challenging to get it repaired by a contractor at the peak of the pool season.

Mr. Sacco suggested filing with the magistrate to attempt to recover the costs of these repairs from American Pools, since they were responsible for the winterization of the pool at the end of the season last year.

A resident suggested temporarily using plastic baby pools this year. Mr. Hogan stated that this would not be allowed because the Glencannon pool is considered a public pool and must follow state health depart-

ment guidelines.

A resident expressed concerns about slippery floors in the pool restrooms, and said that her son recently slipped and fell there. She also said that there were no ice packs available at that time. Mr. Hogan stated that there should be ice packs available in the first aid kit at the pool, and he will check to make sure they are there. Mr. Sarver said that they will check on the non-slip surface in the bathrooms.

Mr. Hogan mentioned that there have been issues with residents not having pool passes. Mrs. Minshull stated that the 90 residents who had their photos taken prior to the pool opening have all received their passes by mail. Others are having their photos taken by the pool staff on an ongoing basis and Mrs. Minshull will be periodically making passes for these residents as well.

Mr. Sarver stated that ten new lounge chairs need to be purchased for the pool area. The lowest price Mrs. Minshull found for these chairs was \$128 each. Mr. Sarver made a motion to purchase ten chairs at this price. Mrs. Ackerman seconded the motion. Vote: 7 yes (Mr. Sarver, Mrs. Ackerman, Mr. Sacco, Mr. Flood, Ms. Manolas, Mr. Morton, and Mr. Creighan)

ACC: Mr. Sarver said that a few ACC requests have been received and approved in the last month.

OLD BUSINESS: Mrs. Ackerman reported that Rich Egnosak and Judi Agostinelli have coordinated advertising of the community yard sale on June 18th.

Mr. Flood mentioned that the abandoned Ford Explorer on Hickory Circle is still there and is taking up a parking space that is needed by other residents. The Board has had difficulty finding someone to tow it. Amy Puglisi stated that in the past the association had John's Automotive in Canonsburg tow abandoned vehicles for no charge. Mrs. Minshull will check into this.

Mrs. Ackerman asked if everyone was satisfied with the new landscaping at the entrances to Glencannon and discussed the arrangements for watering it.

NEW BUSINESS: Mrs. Ackerman stated that she would like to organize a Hot Dog Day at the pool in July. Mr. Sarver mentioned that April John had volunteered to help with this as well. Plans for Community Day were discussed, and Mr. Sarver stated that Vicki Falleroni and April John had both expressed an interest in helping to organize this event. Ms. Falleroni stated that she already has a committee in place to assist her. August 13th was selected as the day of Community Day. Mrs. Ackerman made a motion to have Ms. Falleroni chair the Community Day committee. Mr. Creighan seconded the motion. Vote: 5 yes (Mr. Sarver, Mrs. Ackerman, Mr. Flood, Ms. Manolas, and Mr. Creighan) and 2 abstentions (Mr. Sacco and Mr. Morton)

Nominations were accepted for the Board vacancy in the Townhouse category that will expire in 2013. The nominees were April John, Dorothy Esposto, and Brent Adams. A vote was conducted among the Board members by secret ballot. Five votes were submitted. Ms. Esposto received two votes, Mr. Adams received two votes, and there was one abstention. Ms. Esposto and Mr. Adams were asked to introduce themselves and explain why they wished to be on the Board. A second vote was then conducted. Six votes were submitted. Ms. Esposto received one vote, Mr. Adams received four votes, and there was one abstention. Mr. Adams was elected to the Board.

Nominations were accepted for the three Board seats that will be filled at the Annual Meeting in July. All members were invited to be included in the nominations. The nominees for the Single Family vacancy were Tony Sacco and Brian Spicer. [Following the meeting, Mr. Spicer rescinded his nomination and requested that his name be removed from the ballot.] The nominees for the Townhouse vacancy were April John and Dorothy Esposto. The nominee for the Open vacancy was Rita Manolas. Official ballots for voting will be mailed to all residents.

OPEN DISCUSSION: Glencannon resident Cheryl Cokley discussed the lawsuit she is planning to file against certain Board members. Mr. Spicer requested that the exact numbers of votes from the community vote on

the pond be published in the next issue of the newsletter. Mrs. Minshull confirmed that she has these numbers, and Mr. Sarver agreed that they will be published in the July newsletter. Resident Terry John suggested that the Board have a "warden of the board" to help maintain order at meetings. Mr. Sarver said that the Board will consider this. Mr. Adams discussed the issue with the lightpost that is on his neighbor's property but is connected to his electrical system and is blowing his breaker box. He was told by a North Strabane code inspector that, by law, he cannot be billed for electricity for the lightpost when it is not on his property. He said that the lightpost is going to be disconnected from his electrical system.

Mr. Sarver made a motion to adjourn the meeting. Mr. Flood seconded the motion. Meeting was adjourned at 10:08 p.m.


