As a reminder, under Act 180, the Association has 10 days to provide the resale certificate and other items to the seller. Please notify the Association Secretary as soon as possible so that a resale certificate can be prepared.

The fee for a resale packet is \$75.

## Glencannon Executive Meeting Minutes

September 20, 2011

**Board members present:** President Rita Manolas, Vice President April John, Tony Sacco, Terry Creighan, Richard Flood, Lisa Ackerman. Dave Sarver arrived towards the end of the meeting.

Meeting was called to order by Ms. Manolas at 7:34 p.m.

The minutes from the August Executive Meeting and September Regular meeting were reviewed. It was determined that email votes would be conducted to approve these minutes, to give everyone more time to review them. [The results of the vote on the Executive Meeting minutes from 8/23/2011 were: 6 yes (Mr. Sacco, Mr. Sarver, Mrs. John, Ms. Manolas, Mr. Flood, and Mr. Creighan) and 3 abstentions (Mr. Morton, Mr. Adams, and Mrs. Ackerman). The results of the vote on the Regular Meeting Minutes from 9/13/2011 were: 5 yes (Mr. Sacco, Mrs. John, Ms. Manolas, Mr. Flood, and Mr. Creighan) and 4 abstentions (Mr. Morton, Mr. Adams, Mr. Sarver, and Mrs. Ackerman).]

The leadership of the pond committee was discussed. Mr. Creighan made a motion to appoint John Ackerman as chair of the pond committee. Mrs. Ackerman seconded the motion. Vote: 5 yes (Mr. Creighan, Mr. Flood, Mrs. John, Mrs. Ackerman, and Ms. Manolas) and 1 no (Mr. Sacco).

Ms. Manolas and Mrs. John discussed their meeting with Attorneys Sweat and Cruny regarding the new procedures for filing liens on delinquent accounts.

Mrs. John said that the fall bonfire will be held on October 22nd at the pond. The time will be announced on the bulletin board.

Ms. Manolas made a motion to adjourn the meeting. Mrs. Ackerman seconded the motion. Meeting was adjourned at 8:56 p.m.

#### Glencannon Regular Meeting Minutes

October 11, 2011

**Board members present:** Vice President April John, Tony Sacco, Terry Creighan, Richard Flood, Lisa Ackerman, and Dave Sarver

Meeting was called to order by Mrs. John at 7:13 p.m.

FINANCIALS: The Board reviewed the financial information for September 2011 that had been distributed prior to the meeting. Mrs. John mentioned that there are currently three outstanding invoices that cannot be paid due to a low balance in the regular checking account. Mr. Sarver clarified that these invoices are not yet late, and added that one of the larger invoices is being questioned. It was decided that these invoices will be paid later in October if funds are available then. Mr. Sarver asked if it had been confirmed that the September invoice from Lum's Electric

was not a duplicate, since it included charges from early 2011. Mrs. Minshull said that it did not appear that these charges had been billed previously, but she would research it to be sure. The Board decided to table the vote on the financials until the Executive Meeting.

**OPEN DISCUSSION:** Resident Consuelo Fossum suggested that the Board begin adhering to formal rules of order in their meetings. Board members agreed that this would be a good idea.

**COMMONS:** Mrs. Ackerman reported that a Commons committee meeting was recently held. Decorative cornstalks have been placed around the pond.

**REC CENTER:** Mr. Creighan asked Patrick Hogan to discuss the bids for the work on the baby pool. Mr. Hogan reported that he has obtained a \$6,800 bid from Sherwood Pools. He has also attempted to obtain a bid from Pool and Spa Outlet, but he has not yet received a response. Mr. Hogan will send a copy of this bid to Mrs. Minshull, and she will distribute it to the Board via email.

SOCIAL COMMITTEE: Mrs. John and Mrs. Ackerman spoke about plans for the upcoming Fall Bonfire. Options for music were discussed. Mr. Sacco asked why the Association should pay an additional \$200 for the band [compared with the cost last year] considering the current financial situation. Mrs. Ackerman made a motion to spend \$550 for cleanup, supplies, and a four-member live band for the event. Mr. Flood seconded the motion. Vote: 4 yes (Mrs. Ackerman, Mr. Flood, Mr. Creighan, and Mrs. John) and 2 no (Mr. Sacco and Mr. Sarver).

ACC: No report.

**OLD BUSINESS:** Mrs. John stated that Mrs. Minshull has received phone calls from two of the delinquent property owners who were contacted by the attorneys regarding liens being filed on their properties. To avoid having these liens filed, these residents will attempt to work out payment plans that will be acceptable to the Board.

Mrs. John reported that the pond lawsuit is going well. The Board has a meeting scheduled for October 25th to review the report from the expert witness.

Mrs. John reported that the lawsuit filed by a resident against Glencannon Homes Association, Inc., Dave Sarver, Richard Flood, Lisa Ackerman, and Terry Creighan was dismissed by the Court and Judge John F. DiSalle, Jr. A resident asked if the Association had any financial responsibility related to this case, and Mrs. John said that the Association is responsible for paying the \$1,000 deductible [for the Directors and Officers insurance policy] that resulted from this lawsuit. A resident asked if the Board will pursue recovering this cost from the resident who filed the lawsuit. Mr. Sacco mentioned that recovering this amount would likely require another lawsuit.

**NEW BUSINESS:** Mrs. John said that the November Regular Meeting will be held at the North Strabane Fire Department at 7:00 p.m. on November 8th. The Fire Department is letting the Association hold all future meetings at that location free of charge. Mrs. John thanked resident Brian Spicer for making this suggestion to the Board.

Mrs. John made a motion to adjourn the meeting. Mr. Flood seconded the motion. Meeting was adjourned at 8:34 p.m.
