Any resident planning to change the exterior of their property must obtain approval from the A.C.C. Chairman. North Strabane Township will not issue a building permit to any resident of Glencannon unless they have this approval from the Association. REMINDERS!

Glencannon ACC regulations require that GARBAGE CONTAINERS be stored indoors or *inconspicuously* outdoors (not in front of your residence). Garbage containers should be placed in front of your residence no earlier than 6:00 p.m. the night before collection day, and should be removed following collection on collection day. Thank you!

Also, we ask that residents please remember that Pennsylvania and the township of North Strabane have laws pertaining to DOGS.

Pennsylvania State Law: All dogs must be under control and may not be allowed to run at large. Dogs are personal property and owners are responsible for damages caused by their dogs. This means that when your dog is not on your property, it must be under the direct control of you or a handler. The best way to control your dog is with a leash.

North Strabane Township Ordinance:

It shall be unlawful for the owner of any dog or dogs to allow or permit such dog or dogs to run at large in the township of North Strabane.

We ask that all residents please leash all pets and clean up after them. Thank you for your cooperation.

Glencannon Executive Meeting Minutes July 17, 2011

Board members present: Vice President Dave Sarver, Lisa Ackerman, Tony Sacco, Richard Flood, Rita Manolas, Terry Creighan, Brent Adams, and April John

Meeting was called to order by Mr. Sarver at 7:04 p.m.

Mr. Sarver mentioned that nominations for Board positions in 2012 will need to be made in January in order to adhere to the bylaws.

Mr. Sarver emphasized that it is important for Board members to remain impartial when dealing with matters such as the election.

The minutes from the June Executive Meeting on 6/28/2011 were reviewed and corrections were made. Mr. Sarver made a motion to approve the June Executive Meeting minutes. Mr. Flood seconded the motion. Vote: 6 yes (Mr. Sarver, Mr. Flood, Mr. Creighan, Mr. Sacco, Mr. Adams, Ms. Manolas), 1 no (Mrs. Ackerman) and 1 abstention (Mrs. John)

Discussion took place regarding the May Executive Meeting minutes that had not yet been approved. An email vote will be conducted to approve these minutes. [The results of this email vote were: 3 yes (Mr. Flood, Mr. Creighan, and Mrs. Ackerman), 2 no (Mr. Sacco and Ms. Manolas), and 2 abstentions (Mr. Sarver and Mr. Morton)]

It was also determined that an email vote will be conducted to approve the July Regular Meeting minutes from 7/12/2011. [The results of this email vote were: 7 yes (Mr. Sarver, Mr. Sacco, Mr. Morton, Ms. Manolas, Mrs. Ackerman, Mr. Flood, and Mr. Creighan) and 1 abstention (Mr. Adams)]

Mr. Sarver reviewed the options for accounting firms to handle the audit for this year. Three bids were obtained. He emphasized that the Board needs to make a decision as soon as possible to ensure that there is ample time to prepare for the audit. Mr. Sacco made a motion to accept the bid of \$4,000 from Stelmack Dobransky & Eannace. Mr. Flood seconded the motion. Vote: 6 yes (Mr. Sacco, Mr. Flood, Mr. Adams, Ms. Manolas, Mrs. John, and Mr. Sarver) and 2 abstentions (Mr. Creighan and Mrs. Ackerman)

Mrs. Minshull reported that \$2,948 in pool income has been received through 7/15/2011. Discussion took place regarding the staffing of the pool, as some residents have reported that lifeguards are often not present in the guard room to check pool passes. Mr. Sacco discussed the issue with the baby pool and suggested plugging the drain. Mr. Sarver said that this idea had been previously considered. Mr. Sacco said he will speak with Mr. Hogan about it.

Mr. Sarver stated that the broken swings at playground "A" have been replaced. Mr. Sarver mentioned the graffiti that was spray painted on Hunting Creek Road near Cricketwood Court. Mr. Creighan said that they have plans to remove it with power washing. Mr. Creighan stated that the large tree

near the Route 19 entrance of Glencannon is growing over the power lines and needs to be trimmed, and perhaps the power company should be contacted to trim their part of it.

Mr. Sacco shared a report displaying the budget consumption to date for this year.

Mrs. Ackerman reported that several businesses and residents donated food and door prizes for the Hot Dog Day that was held at the pool on July 17th. Sam's Club, Giant Eagle, and Trax Farms donated gift cards, Elite Outdoor donated candy and pop, and Joe and Lori Macdonald donated ice. Mr. Adams donated a signed Pittsburgh Penguins hockey puck that was given as a door prize and Mrs. Ackerman donated a Pittsburgh Penguins shirt that was given as a door prize.

Nominations were held for the position of President of the Board of Directors. This term will run through March 2012. Mr. Flood nominated Mr. Sarver for President. Mr. Creighan seconded. Mr. Adams nominated Ms. Manolas for President. Mrs. John seconded. Mrs. Ackerman nominated herself for President. Ms. Manolas seconded. Ballots were collected by Mrs. Minshull. Mr. Sarver received 4 votes and Ms. Manolas received 4 votes. Mr. Sacco made a motion to continue the election of officers until a later date prior to the next regular meeting on August 9, 2011. Mr. Adams seconded the motion.

Mr. Sacco made a motion to nominate Mr. Sarver as Acting President. Mr. Adams seconded the motion.

Mr. Sarver made a motion to adjourn the meeting. Ms. Manolas seconded the motion. Meeting was adjourned at 9:13 p.m.

Glencannon Executive Meeting Minutes July 31, 2011

Board members present: John Morton, Tony Sacco, Richard Flood, Rita Manolas, Terry Creighan, Brent Adams, and April John.

The Board discussed two incidents that occurred in the recent election of Board Members. They also discussed the importance of establishing clarity in various areas of the bylaws, and emphasized the need to clearly define when Board member terms begin and end.

Mr. Morton made a motion to suspend discussion of the election of officers until a later date. Mr. Sacco seconded the motion. Vote: 7 yes (Mr. Morton, Mr. Sacco, Mr. Adams, Mr. Flood, Mr. Creighan, Ms. Manolas, Mrs. John)

Mr. Sacco discussed the projected budget shortfall for 2011 and made suggestions to reduce this shortfall, such as waiting until 2012 to repair the baby pool. Mr. Adams suggested that the pond lawsuit costs should excluded from the regular budget, to ensure that other community services and amenities are not compromised due to the cost of the lawsuit. Mr. Sacco agreed with Mr. Adams, yet expressed concern as to where the

money to pay invoices will be coming from. Mr. Adams made a motion to separate the lawsuit from the regular budget. Mr. Flood seconded the motion. Vote: 7 yes (Mr. Adams, Mr. Flood, Mr. Creighan, Mr. Sacco, Ms. Manolas, Mrs. John, Mr. Morton)

Mrs. John suggested looking into the possibility of foreclosing on seriously delinquent properties if there are no existing mortgages or tax liens on them that would take priority. Mrs. John made a motion to research liens on seriously delinquent properties and take action to foreclose on them if there are no other liens. Mr. Sacco seconded the motion. Vote: 7 yes (Mrs. John, Mr. Sacco, Mr. Adams, Mr. Flood, Mr. Creighan, Ms. Manolas, Mr. Morton)

Mr. Morton emphasized the importance of finding out the proper legal procedures for foreclosing on delinquent properties.

Mr. Sacco discussed the problem at the Rec Center where the deck area is separating from the building. The Board previously voted to spend up to \$1,000 to correct this problem. Mr. Sacco suggested having Ed from Elite fill this gap with foam insulation as a temporary fix to prevent water from entering this area. Mr. Creighan suggested finding out if Ed could permanently fix this problem for under the \$1,000 amount already approved.

The trees in need of trimming on Hickory Circle were discussed. It was decided that an email vote will be conducted to determine if the Board will accept the bid from Staley Tree Service. Mrs. Minshull has tried without success to obtain bids from other tree services.

Mr. Adams made a motion to adjourn the meeting. Mr. Creighan seconded the motion. Meeting was adjourned at 9:21 p.m.

Nominations were held for the position of President of the Board of Directors. This term will run through March 2012. Mr. Sacco nominated Ms. Manolas for President. Mr. Adams seconded. Mrs. Ackerman nominated Mr. Creighan for President. Mr. Flood seconded. Mrs. John nominated Mr. Sarver for President. Mr. Creighan seconded. Mr. Sarver made a motion to close nominations. Mrs. John seconded. Ballots were collected and counted by Mrs. Minshull. Ms. Manolas received 5 votes and Mr. Creighan received 4 votes. Ms. Manolas was elected President of the Board of Directors.

Nominations were held for the position of Vice President of the Board of Directors. This term will run through March 2012. Ms. Manolas nominated Mrs. John. Mr. Adams seconded.
